Approval of the Minutes

Mr. Dangel moved to approve the September 5, 2012 minutes. Mr. Purvis seconded the motion. All voted in favor.

Review Professional Retail Marketing Services Agreement

Mr. Smoak stated the Town will be entering a long term contract with a Professional Retail Marketing Group. The Town received 3 responses to an advertised RFP. Mr. Smoak stated after a 2 month process, along with interviews and reviewing the RFP responses the Town selected The Shopping Center Group. The Shopping Center Group has established relationships with the retail market that can provide the Town with on-going demographic data that the Town needs moving forward. The FBA are looking into the possibilities of hosting a booth reception at the ICSC next year to expand on the relationship with local retailers and developers.
