## Farragut Arts Council Minutes

**Call to Order** : The meeting was called to order at 5:01 p.m. by acting President, Pam Ziegler.

**Approval of September Minutes** : Minutes were approved as presented.

**Barbara West Portrait Group Reception** : Council members were asked to assist in setting up refreshments and to assist in clean-up at close of event.

**Freaky Friday Fright Night** : Lauren informed group that two High School Volunteers would be available to assist Arts Council members in distributing coloring pages/crayons to Trick or Treaters, if needed.

Council members should arrive at Mayor Leonard Park at 4:15 p.m. to avoid traffic and get parking place due to ongoing construction at the park.

**2018 Arts Council Sponsored Event –Pleasant Forest Living History** : Lauren advised that Robert Warren has started on script and has plenty of information. Julia (Museum Director) and Lauren will work together to obtain costumes. The Open Call for Actors will be in January; Arts Council members will be present during review of selecting actors.

**Other**: Pam Ziegler advised there was an urgent need to acquire two upright glass cases to replace the ones currently in use. Vertical cases would allow art to be viewed more easily and would provide more protection to items displaced since glass shelving and rickety supports are not reliable.

Pam will research available vertical cases and report on findings/cost at November meeting. If Arts Council finds proposal feasible, Lauren will present our request to BOMA for inclusion in the 2018-2019 budget.
